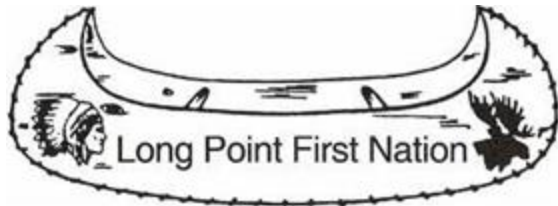

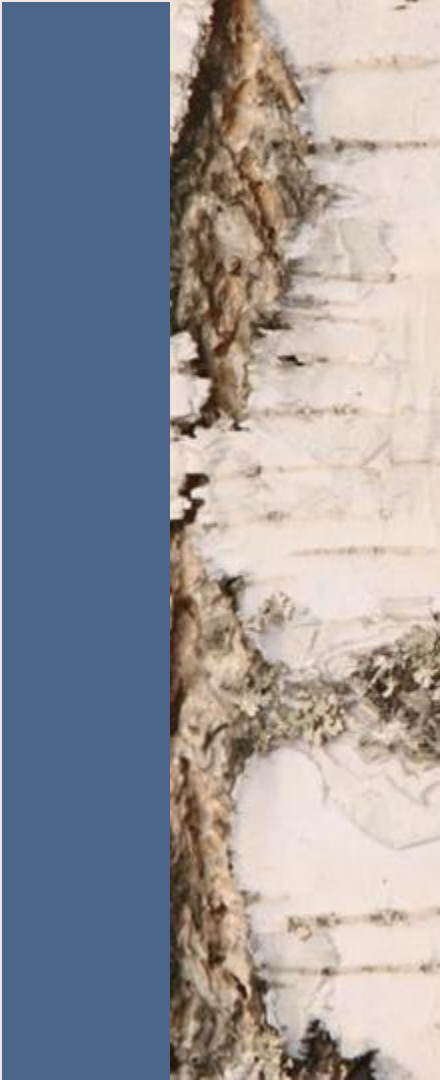

Legal Cautionary Statement about the Crown's Obligations

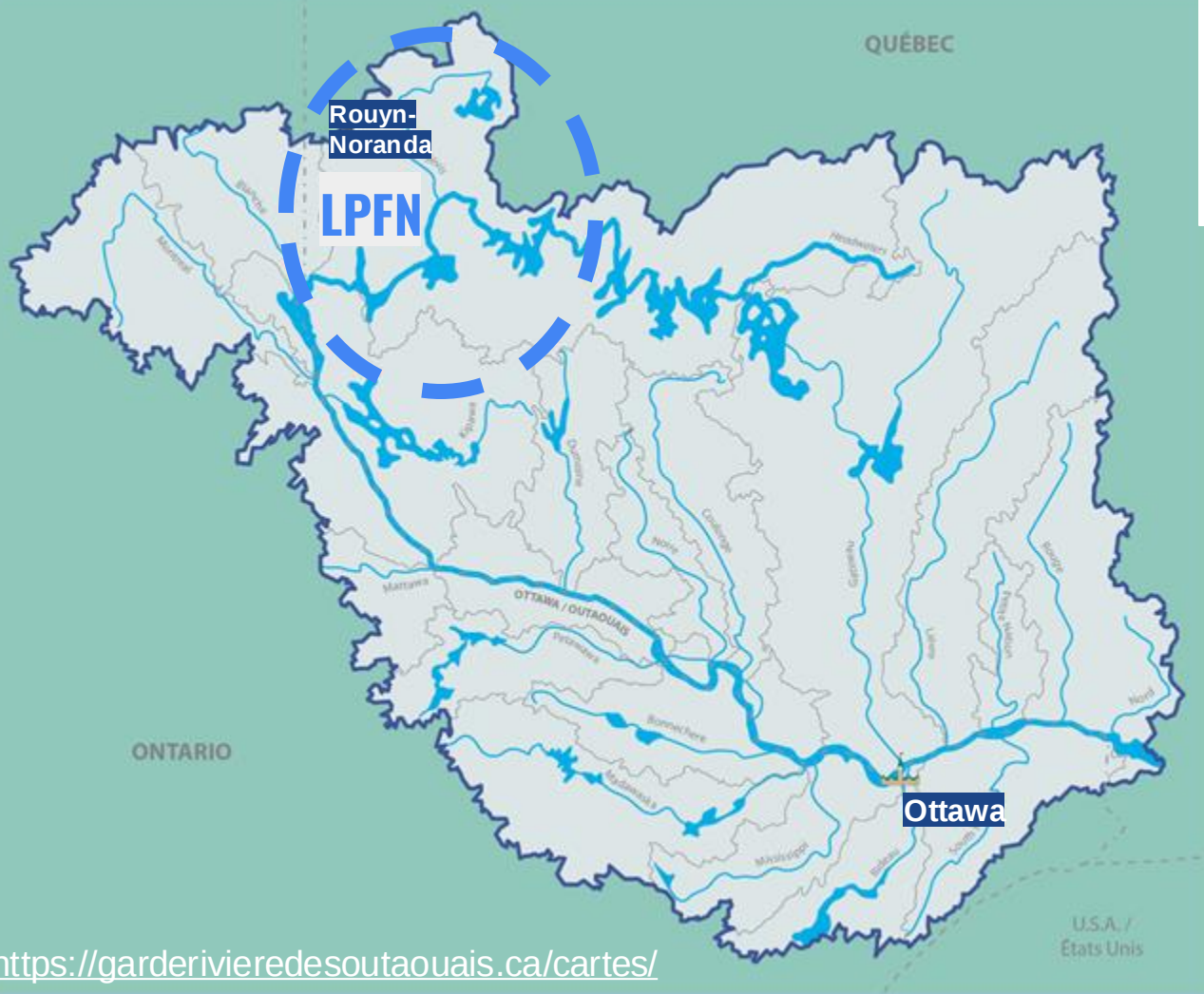

Kichi Sipi (Ottawa River) Watershed

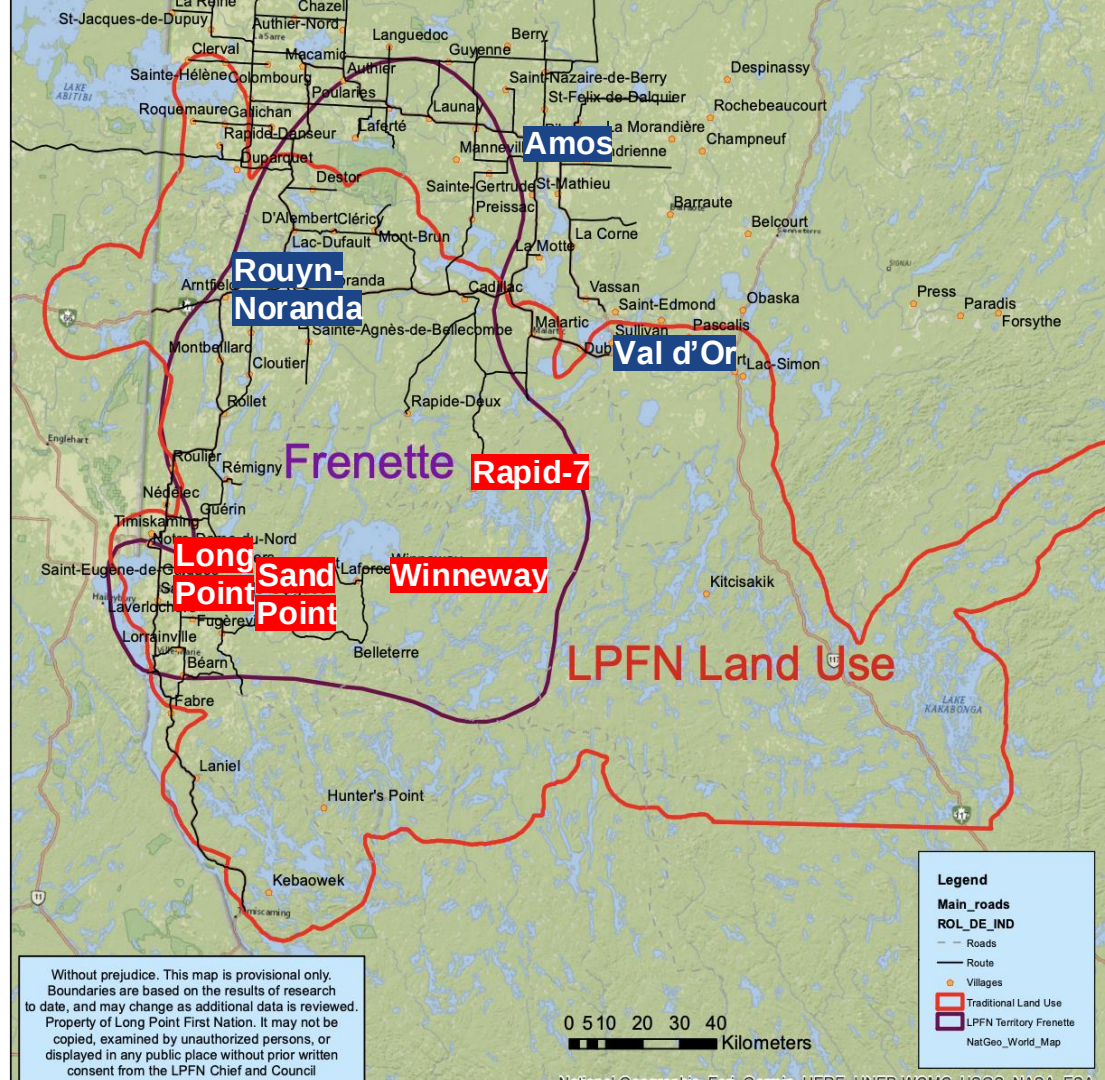

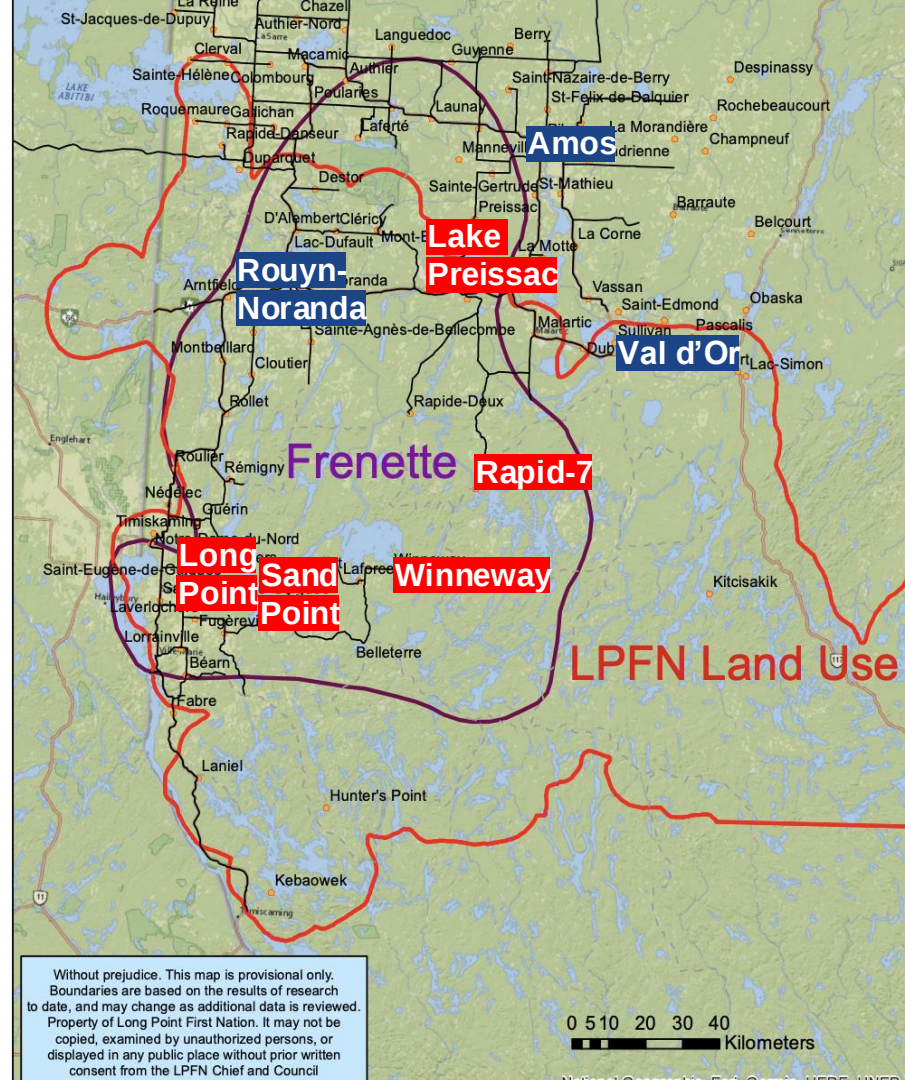

KĀKINWAWIGAK ANICINABE AKI / LONG POINT FIRST NATION (LPFN) ANCESTRAL TERRITORY (CURRENT STATE OF RESEARCH)



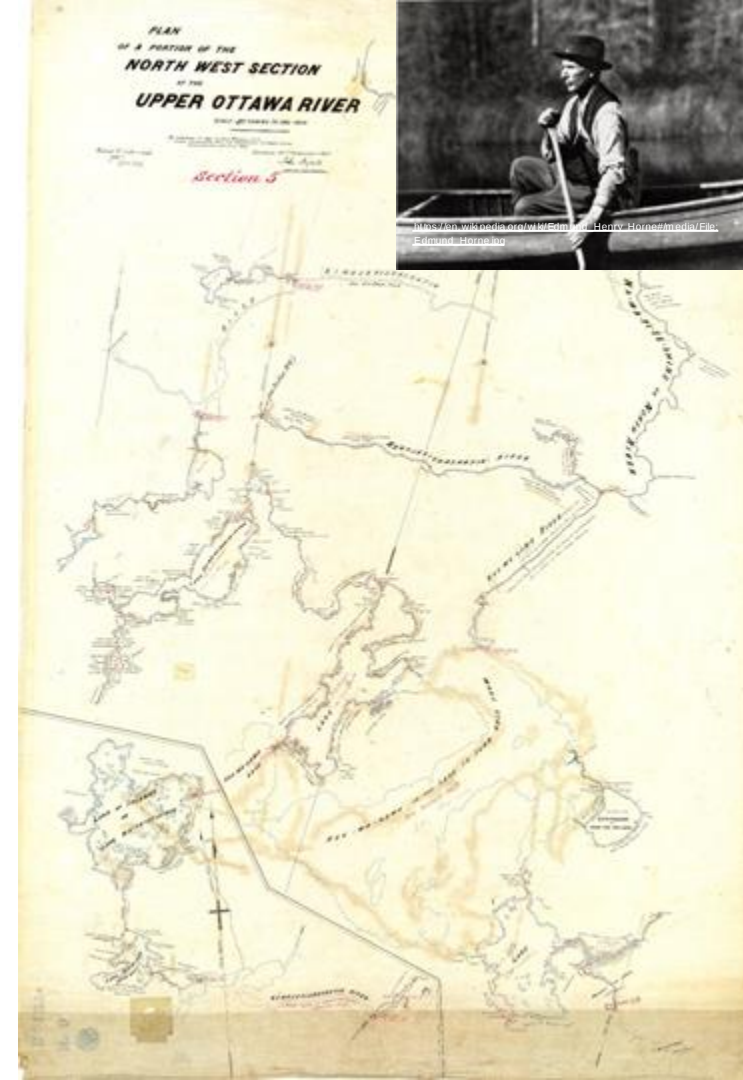
KĀKINWAWIGAK ANICINABE (LPFN) HISTORY & RELOCATION

- **Kākinwawagak (Long Point)** was gathering place for centuries
- **Flooded & forced to relocate** to Neyawagak (Sand Point) after dams built in Angliers 1910-20s
- Discussions for LPFN to go to **Kewagama (Lake Preissac)** in 1910-20s
- **Another flood & forced relocation** at Ka Tackapikedjiwang **Rapid-7 Dam** in 1930-40s
- Eventually LPFN settled in Winneway in 1930-40s
- About 1000 **members** now: half in Winneway, many over the territory



Kākinwawagak Anicinabe (LPFN) Stories About Northern Part of Territory

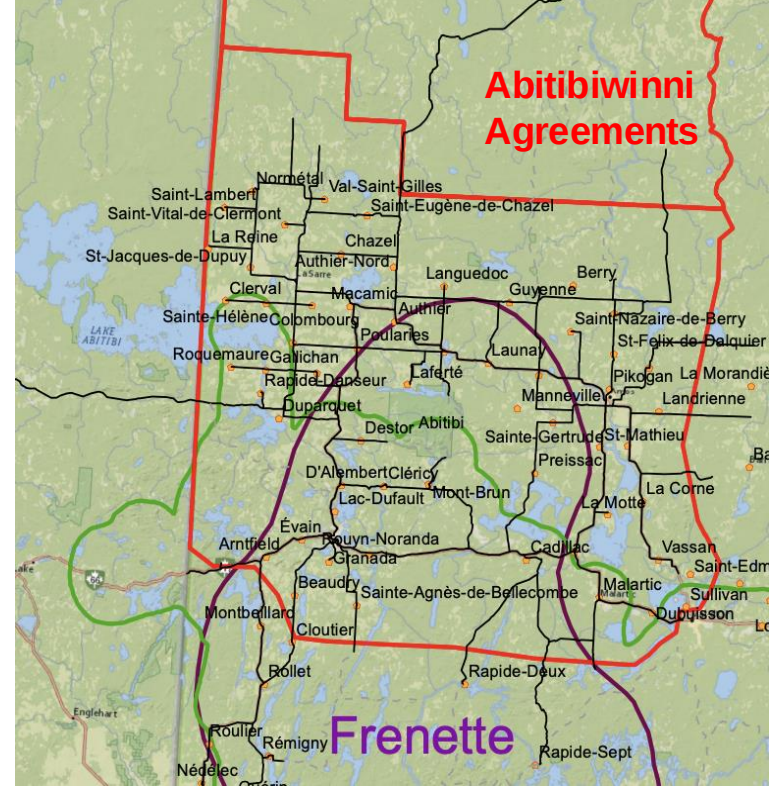
- LPFN member **Makimoot** guiding **Edmund Horne's** discovery ca.1910-20s
- Discussions to settle at **Kewagama (Lake Preissac)** ca.1910-20s
- LPFN toponymy & families using northern territory for generations (Rodgers Lake)
- LPFN members' **baptism certificates** found in McWatters
- Anthropologists **research** (e.g. Jacques Frenette)





2017 & 2022 Agreements between Quebec & Abitibiwinni First Nation **do not take into account LPFN's ancestral territory**

Quebec did not consult LPFN prior to concluding these agreements, which represents a failure of its constitutional duty

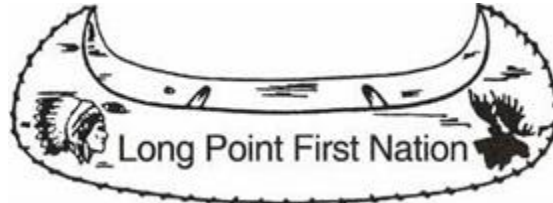

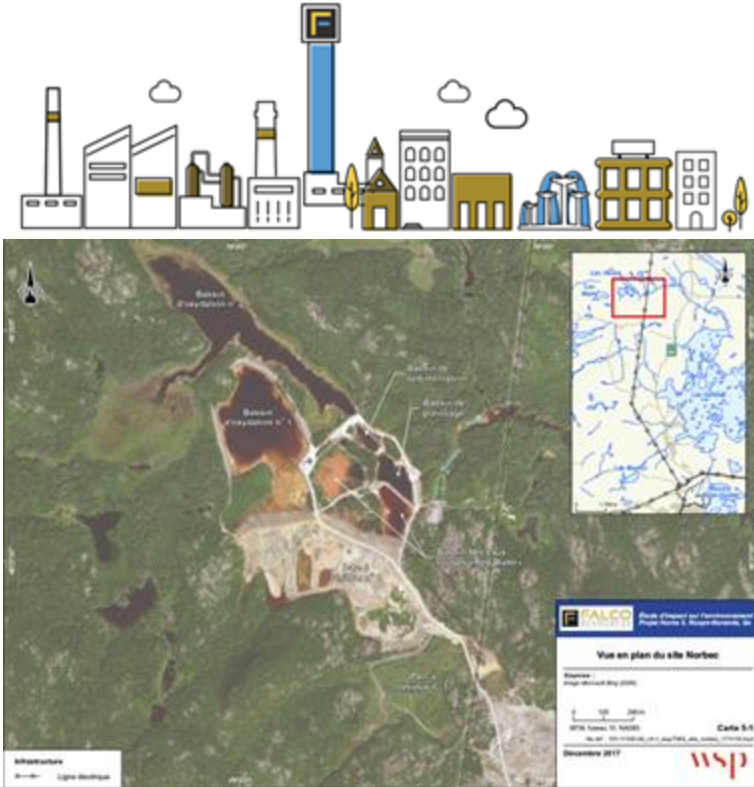
4. WHAT ARE FALCO'S PROJECT POTENTIAL IMPACTS ?
